aving trouble understanding the change-in-terms (CIT) rules for open-end credit transactions? Well, you are not alone. While the CIT rules applicable to home equity lines of credit (HELOCs) have not changed (yet), the CIT rules governing open-end not home-secured credit were substantially revised in July 2010 and can be a bit overwhelming. This webinar is designed to break down the CIT rules for both HELOC and not home-secured credit transactions (including overdraft lines. personal lines of credit and credit cards) and will incorporate several examples of CIT notices (with tabular disclosures, as applicable) beyond the model forms provided in Regulation Z.

HELOCs: We'll cover the permissible changes that may be made to an existing HELOC, when written notice of a change is (and is not) required, and the timing rules for delivery of the notice. Further, we'll discuss the format in which the HELOC CIT notice or agreement must appear.

Not Home-secured Credit: We'll discuss the actions that give rise to providing a CIT notice, including what constitutes a "significant change" under Regulation Z (which may require inclusion of the changed term in tabular format). We'll also review the content requirements for the CIT notice, along with the specific format requirements when providing the CIT notice separately from or as part of the periodic statement.

Finally, we'll address the CIT issues that arise when offering openend not home-secured products (non-credit cards) that are tied to a variable rate index and currently include floor rates.
